

QUORUM AND VOTING RESULTS

The Annual General Meeting of Sacyr, S.A. held on 15 June 2023 on second call was attended (directly or through representatives), including the company's treasury shares, by 679 shareholders, holders of 388,070,532 shares of the Company, representing 58.208% cent of the subscribed share capital with voting rights. Of which:

- In person attendance amounted 150 shareholders, holders of 39,058,876 shares, representing 5.859% of the share capital.
- Attendance by proxy amounted 529 shareholders, holders of 349,011,656 shares, representing 52.349% of the share capital.

The issued share capital amounts to EUR 666,700,774 and is divided into 666,700,774 shares of EUR 1 par value each. The company's Treasury shares amounts to 20,367,374 shares equivalent to 3,06% of the issued share capital.
